examined the documentation submitted by the manufacturer, performed an initial product type test and assessed the factory production control, and found that the specified product meets the requirements determined by the designated construction technical certificate associated with the basic requirements stated in:

**Construction technical certificate (CTC) Reg. No. 12.819.816**

The authorized body has ascertained that the factory production control system corresponds to the relevant technical documentation and ensures that the products put on the market meet the requirements designated by the aforementioned specifications and correspond to the technical documentation pursuant to section 4 paragraph 3.

The integral part of this certificate is the Reports No. 09.415.799 dated 19.12.2016 and No. 12.834.882 dated 13.12.2019, which contain the conclusions of the assessment, verification and results of the tests, and basic description of certified product essential for its identification.

This certificate was first issued on 12.01.2017 and remains valid for the period during which the requirements designated in the stated specifications or production conditions at the place of production or factory production control do not change significantly or unless the authorized body suspends or cancels the validity of this certificate.

At least once every 12 months the authorized body will perform supervision of the due functioning of factory production control pursuant to section 5a of the Government Decree mentioned above.

This is a revision No. 1 of the certificate No. 09.066.089, issued 12.01.2017.

This language version of the certificate is a translation of a Czech official version No. 09.066.089 revision No. 1 issued on 30.04.2020, which is deemed the only one applicable in the event of legal disputes and was printed on 30.04.2020.
